

# Army Information Technology Enterprise Solutions-3 Services [ITES-3S]

---

ITES-3S will replace ITES-2S, a multiple-award contract [MAC] with a ceiling of \$25 billion that was awarded to 16 prime contractors in 2006 and is set to expire in fiscal 2017. ITES-3S will be managed by the Army's Computer Hardware, Enterprise Software and Solutions (CHESS) program and is expected to be the Army's primary source of IT-related services worldwide.

ITES-3S task areas will include:

- cyber security services
- information systems security
- information assurance
- IT services
- business process re-engineering
- enterprise design
- integration and consolidation
- network/systems operation and maintenance
- telecommunications/systems operation and maintenance
- IT supply chain management; and
- IT education and training.

The ITES-3S is expected to offer various task-order types:

- firm-fixed-price
- cost-type, and
- time-and-materials.

It is not yet known if ITES-3S will include two separate solicitations based on business size, the Army expects to highlight more small-business participation on ITES-3S. The change in the NAICS code for ITES-3S to 541519: Other Computer Related Services from 517110: Wired Telecommunications Carriers, which has a small business size standard of \$27.5 million was likely selected to increase the potential pool of IT services vendors that qualify as small businesses.

The current contractors on the ITES-2S MAC are listed below and will most likely bid on the ITES-3S RFP and will make good teaming/partnering IT service vendors looking to go after this contract.
